## 1. ROLL CALL

The meeting was called to order at 7:38 p.m. by President Barbara Struthers. Trustees Tony Bilotti, Susan Levy, Roger Simonson and Dan Rubin were present. District Attorney Robert J. # 3. **MINUTES**

A. <u>Clarke Report</u> –Mr. Balis advised that because of the weather helicopter larvaciding has been rescheduled to May 18. This treatment has a 30 day effectiveness. Larval inspections in Riverwoods, Bannockburn and few areas in Highland Park have taken place. The traps are scheduled to be placed on May 18. He also said that the Clarke portal is now up and running for the reporting of standing water. The portal is linked up through the District website.

Trustee Levy inquired if additional services may be needed near Ravinia Park as a result of the event season being cancelled. Mr. Balis said Ravinia is going to be using the park at times for other reasons and the management has elected to continue the regular treatments.

President Struthers said that the trifold brochures have been received and distribution will begin via usual manner.

The trustees then discussed the apparent desire of certain members of the County Board to eliminate the District.
