1. **ROLL CALL**

6. **REPORTS**

A. Clarke Report

Mr. Balis stated that June was dry and warm. Lake County had higher than normal precipitation whereas O'Hare reported lower precipitation. He stated that all sites are being counted and if more than 70-75 found in a count, then adult treatments are completed. 25 counties have had positive samples for WNV. Clarke looks at other areas for comparison due to flight of the mosquitoes. Mr. Balis stated that villages can request services for specific events, like the Deerfield fireworks.

Mr. Balis said the most calls to Clarke had been nuisance counts of mosquitoes. Clarke looks at all data and not just calls to determine if treatment will be done. He also said that articles in newsletters will be done and he is willing to share the language for other publications if requested.

7. **OLD BUSINESS**

Trustee Kasdin stated that she had a phone conference with Revive regarding website and District communications. The individual she spoke with said they would respond to the RFP but did not give a quote at this time. The trustees then discussed if bids could be for just a portion of the RFP and not all services and it was agreed that they would accept those bids. President Ross said that he will reach out to other website companies that do municipal work. It was also discussed that a possible intergovernmental agreement with NSMAD will be investigated.

8. **NEW BUSINESS**

Attorney Gurysh explained the requirement to have a Decennial Committee to report to the County about the policies and procedures of the District as well as ways that the District tries to keep spending low. It was stated that 2 members of the public as well as all trustees must be members of the committee. Mayor Ford stated that she had someone she thinks would participate and Trustee Dadey said she would ask some people as well. The District will try to hold a committee meeting at the August meeting.
